3. 轉交個人資料

本公司及其香港股份過戶登記分處所持有關證券持有人的個人資料將會保密,但本公司及其香港股份過戶登記分處可以在為作上述任何用途之必要情況下,向下列任何人士披露或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理,例如財務顧問、收款 銀行和海外股份過戶登記總處;
- (如證券申請人要求將證券存入中央結算 系統)香港結算或香港結算代理人,其將 會就中央結算系統的運作使用有關個人資 料。;
- 向本公司或香港股份過戶登記分處提供與 其各自業務營運有關的行政、電訊、電 腦>付款或其他服務的任何代理、承包商 或第二方服務供應商;
- (基於遵照法例、規則或法規的規定) 聯交 所、證監會及任何其他法定監管機關或政 府部門或其他對象;及
- 證券持有人與其進行或擬進行交易的任何 人士或機構,例如彼等的銀行、律師、會 計師或股票經紀等。

4. 個人資料的保留
